## **Purpose**

NUIST-Reading Academy is the University of Reading's joint institute in China, in partnership with Nanjing University of Information Science and Technology, which offers eight undergraduate and two postgraduate taught programmes. More than one thousand students are enrolled with the University of Reading in Nanjing, and a proportion transfer to Reading UK for some of their studies. Teaching in Nanjing is delivered on an enhanced franchise model by academic staff employed by NUIST, which also has local responsibility for the provision of student services.

The ADTL for NUIST-Reading Academy is responsible for academic quality and standards in respect of Nanjing-based students. The role is based in the UK but includes regular visits to work with staff and students at NUIST. The ADTL is responsible to University Board for Teaching and Learning and the Student Experience (UBTLSE). A key focus of the role is to guarantee a comparable student experience, and equal academic standards, to what is offered to UoR students on other campuses.

# Main duties and responsibilities

The ADTL (NUIST Academy) is expected to fulfil, in collaboration as appropriate, all the following responsibilities:

- Provide guidance to NUIST academic staff on the delivery of undergraduate and postgraduate teaching as set out in the operational handbook
- Give academic leadership in the following areas:
  - Promotion of collaboration in teaching and learning between the University and NUIST
  - Supporting NUIST Academy academic staff to ensure delivery of teaching is continuously improved and developed
  - Working closely with the Vice Deans of Teaching and Learning at NUIST Academy to ensure that academic standards, and quality management and assurance, are maintained
  - o Ensuring that relevant UoR teaching and learning policies are followed at the Academy
  - Coordinating across UoR Schools and NUIST on assessment matters and the application of assessment policy
- Coordinate the maintenance, review and enhancement of academic provision at NUIST Academy, taking a cross-programme approach to ensure consistency, and making recommendations to UBTLSE as appropriate
- Maintain oversight of teaching operations so that best practice is observed both by Nanjing- and Reading-based staff
- Engage in, and contribute to, UoR processes for the annual monitoring of collaborative provision
- Apply the University of Reading's Academic Engagement and Fitness to Study policy, as appropriate, in the case of Nanjing-based students

The ADTL may also have a role approving suspensions, extensions and exceptional admissions arrangements for undergraduate and taught postgraduate students in NUIST Academy.

At NUIST, the role works closely with the Vice Deans of Teaching and Learning at NUIST Academy, as well as other Academy staff. In the UK, the role works closely with SDTLs, Teaching and Learning Deans, Programme Directors, CQSD, Examinations, the support centres and professional staff in ISLI, as appropriate.

### **Terms and conditions**

The appointment is based in ISLI and fills between 0.5 and 0.7 FTE in workload, on average, across the academic year. The precise distribution of time in role will depend on the nature of other commitments in each teaching term or semester. The appointee should expect to make three or four visits to Nanjing each year.

The role does not include teaching at NUIST, but it is possible to combine the ADTL role with NUIST-based teaching responsibilities.
