EMERGENCY POWERS (DEFENCE)

Food (Labelling)

ORDER, DATED APRIL 27, 1945, AMENDING THE LABELLING OF FOOD (No. 2) ORDER, 1944, AND GRANTING A GENERAL LICENCE THEREUNDER.

In exercise of the powers conferred upon him by Regulation 2 of the Defence (Sale of Food) Regulations, 1943(a), and of all other powers him enabling, the Minister of Food hereby makes the following Order:

- 1. The Labelling of Food (No. 2) Order, 1944(b) (hereinafter referred to as the "Principal Order"), shall be amended as follows:-
 - (a) by inserting in the First Schedule thereto, after the words "Curry Powders "appearing in entry No. 9 in Table A (which specifies certain foods exempt from paragraph (3) of Article 2 of the Order to the extent that their ingredients need not be specified) the words "Ice cream";
- (b) by substituting in Table C in the said Schedule (which relates to food of which the ingredients need not be specified so long as the food complies as regards composition with the requirements of the Orders named in the Table) for the entry relating to canned fruit the following entry:

Canned fruit and canned vegetables if specified in Part I of the First Schedule to the Order in Column 2.	The Canned Fruit and Vegetable Order, 1945 (S.R. & O. 1945 No. 460).

2.—(I) Pursuant to Article 14 of the Principal Order the Minister of Food hereby grants the following General Licence: -

During the continuance of this Licence the following foods, that is to say, custard powder, free running salt and iodised salt shall be exempt from paragraph (3) of Article 2 of the Principal Order (which relates to the retail sale of pre-packed foods) to the extent that the ingredients of such foods need not be specified; and Article 3 of the said Order (which applies when food is delivered pursuant to a sale otherwise than by retail) shall have effect accordingly.

- (2) This General Licence shall cease to have effect—
- (a) as respects the sale by retail or display for sale by retail of the above mentioned foods, on the 30th day of April, 1946;

- (b) as respects the delivery of such foods pursuant to a sale otherwise than by retail—
 - (i) on the 31st day of October, 1945, where the delivery is pursuant to a sale by the packer or labeller of the food; and
 - (ii) on the 31st day of January, 1946, where the delivery is pursuant to any other sale.
- 3. This Order shall come into force on the date hereof.

EXPLANATORY NOTE

The purpose of this amending Order is to permit the sale of ice-cream and canned vegetables, without a declaration of the ingredients appearing on the label. Canned vegetables must, however, comply as regards composition with the requirements of the Canned Fruit and Vegetables Order, 1945. A similar exemption from declaration of ingredients is also provided for a limited period for custard powder, free running salt and iodised salt.
