Dear Mr Borrell Fontelles,

As Chair of the European Food Safety Authority's Management Board and as Acting Executive Director of EFSA we would like to express our deep concern over the Council's Common Position on the Financial Framework 2007-2013 and in particular the implications of the 'freezing' of Heading 3B under which the Authority is financed.

As you are aware EFSA was established as a result of various food crises across the European Community, including BSE and dioxins. It became operational only in 2003, providing the robust scientific basis for food and feed safety legislation, and, by being the keystone of European Union (EU) risk assessment regarding food and feed safety, rebuilding consumer and trading partners' confidence in the European food supply. Since its establishment EFSA has developed a reputation for its scientific excellence and, openness and has striven to build close links with national food safety agencies, consumers and other stakeholders to meet the goals of the legislators to provide a high level of protection of human life and health and rebuild confidence in the European food supply.

The Authority is still in a critical development phase and freezing the budget at current level will inevitably affect its ability to provide the scientific basis for legislation in the area of food and feed safety, which is its raison d'être. This would not only impact on activities set out under the existing legal framework but also call into question much of the work foreseen under new or planned legislation – e.g. in relation to the scientific work needed to support Community policies on nutrition and obesity. Attached to this letter you find an overview of possible effects of budget reduction on EFSA's activities

after 2006 resulting from the Council's Common Position on the Financial Framework 2007-2013.

In addition, EFSA, with the endorsement of the European Parliament, has made commitments to the authorities in Parma concerning the building of its final headquarters and indeed would face financial and legal difficulties if its budget were to be frozen.

EFSA is at the forefront of the scientific work on the protection of consumers from risks arising from the contamination of food, assessing the risks of pesticide levels in foods, examining the best ways to prevent the spread of Foot and Mouth Disease and other exotic diseases in animals and more recently has been at the forefront of the work on the identification of the routes of spread of avian influenza from Asia to Europe, engaging in several in-depth scientific studies to ensure that EU policies in this area are based on sound science.

It is with deep regret that we have to inform the European Parliament that the freezing of the budget envisaged will have severe implications on the Authority's work which in our opinion will lead once again to an erosion of consumer and trading partners' confidence in European food and feed, and potentially to a detriment in consumer protection. Industry will also be affected. The Authority's ability to assess dossiers for the ultimate marketing of food and substances used in foods and feeds will be stymied with the net result that industry will be held back in its ability to compete on the world markets. We have illustrated some of these issues in annex.

Therefore we would like to ask the European Parliament to look closely at the allocation to Heading 3B and in particular ask that the importance of the work of the Authority is underpinned by proper financial support in any further discussion on the Financial Framework for 2007-2013.
