

# Animal Welfare and Ethical Review Body (AWERB)

17/19 A meeting of the Animal Welfare and Ethical Review Body (AWERB) was held in Edith Morley Room 128 on Friday 13 October 2017 at 10.00 am.

### 17/20 Minutes of the last meeting

The minutes of the last meeting held on 10 February 2017 were approved.

### 17/21 Matters Arising

17/13 17/03 Communications informed by feedback from the UAR visit AWERB received and noted a report from [Redacted, Sec. 40] outlining progress to date and achievements made during 2016/17 as the first year as a Concordat signatory. The paper also included plans for further improvements on openness and communication about animal research.

AWERB discussed additional information that could be disclosed in the spirit of openness, in particular: severity data, the summaries provided to the Home Office, and mid-term reviews. It was suggested that it would be helpful to include timelines and named actions against the areas for further improvement in the report. Members of AWERB were asked to provide any further comments on the content of the paper to [Redacted, Sec. 40]. The report could then be used as the basis of annual update to UAR on progress on openness.

## 17/23 Health and Life Sciences Building

[Redacted, Sec. 40] provided an updated report to AWERB in relation to welfare and ethical issues in the BRU and the move to the new Health and Life Sciences Building.

### It was reported that:

- The [Redacted, Sec. 40] had been working with project holders and the University's contact at Harwell to produce a preliminary move programme for each research project that was likely to be in place when the new building opens.
- There were a number of complexities, including: unknowns related to the success or failure of grant applications submitted between now and the occupation of the new unit; difficulties in trying to predict experimental activities to be undertaken in 2019; a lack of information from new staff who had not yet formulated or articulated their plans to the level of detail required.
- In terms of animal welfare, the two main requirements that presented cost and/or time implications related to higher health status and increased technical resource.
- Options, costs and timelines had been explored which varied between £130k and 8.5 months, and £190k and 5.5 months.
- Where commercial suppliers were contracted to provide rederived strains, dates for recovery of cryopreserved stocks and/or expansion of stock needed to be defined accurately to ensure that colonies were not expanded early and unused; a rigid adherence to the official handover date was essential to avoid wastage of animals and increased costs.
- In order to support two units in the short-term more technical resource would be required.

AWERB agreed that it would be helpful for a report on issues associated with the move to be submitted to the University Committee on Research Infrastructure and for a briefing to be given to [Redacted, Sec. 40].
