

## UNIVERSITY OF READING: PRIZE DRAW TERMS AND CONDITIONS

**By entering the prize draw you agree to be bound by these terms and conditions.**

1. **Promoter.** The promoter of this prize draw is the University of Reading, a corporation with charitable status, established by Royal Charter (RC000665), of Whiteknights House, Whiteknights, PO Box 217, Reading, Berkshire, RG6 6AH, United Kingdom.
2. **Eligibility.** This prize draw is only open to residents of the UK or individuals studying in the UK aged 18 years or over. Employees of the Promoter, their family members, or any person directly involved in the running of the prize draw, are not eligible to enter. The Promoter may ask the winner(s) to provide proof of age.
3. **How to enter** To enter the prize draw [take pictures of your clean and tidy house, front garden, back garden and bins when you move out of your private accommodation and send them by email to [community@reading.ac.uk](mailto:community@reading.ac.uk). Make sure to include the full names and student numbers of you and your housemates, as well as your term time address when you send in your entry.] All entries must be submitted [by email to [community@reading.ac.uk](mailto:community@reading.ac.uk)], using your University email address] and only one entry per person is permitted. No purchase is necessary to enter this prize draw.
4. **Opening and Closing Date.** Entries can be submitted between [09:00 GMT] on [23 May 2023] and [23:59 GMT] on [01 July 2023] (**Closing Date**). Entries received after the Closing Date, or invalid or ineligible entries, will be disqualified.
5. **Prize Draw.** The winner(s) will be chosen at random from all valid entries [via an online random number generator] within one month of the Closing Date.
6. **Prize.** The prize(s) available to be won:
  - (i) £100 ASDA voucher x1
  - (ii) £50 Deliveroo vouchers x2
  - (iii) £50 Cafe Yolk vouchers x2
  - (iv) A Year's Supply of Pasta

If a winner cannot be contacted or does not claim the prize within fourteen (14) days of being notified, the Promoter reserves the right to re-draw at random and offer the prize to the next eligible entrant.
8. **Decision of Promoter.** The decision of the Promoter regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

10. **Suspension / Cancellation of Prize Draw.** The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

11. **Liability.** The Prize is provided 'as is' without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement. The Promoter does not accept any responsibility for product warranty and/or product liability matters. The Promoter's total liability to you in relation to the prize draw and/or the prize(s) shall not exceed the value of the prize(s).
