EMERGENCY POWERS (DEFENCE)

Food (Saccharin)

Order, dated May 5, 1943, amending the Saccharin (Control and Maximum Prices) Order, 1942.

In exercise of the powers conferred upon him by Regulation 55 of the Defence (General) Regulations, 1939, as amended, and of all other powers him enabling, the Minister of Food hereby makes the following Order:—

- 1. The Saccharin (Control and Maximum Prices) Order, 1942(a), shall be amended—
 - (a) by substituting for paragraph (a) of Article 2 thereof the following paragraph:—
 - (a) buy by retail or sell by retail any saccharin solution, dulcin solution saccharin in powder form, dulcin in powder form, soluble saccharin or sweetening powder, provided that the restrictions imposed by this paragraph shall not apply to the purchase by or sale to a registered medical practitioner (for pharmaceutical purposes) of saccharin solution, saccharin in powder form, or soluble saccharin; "
 - (b) by inserting in paragraph (1) of Article 3 thereof after the words "soluble saccharin" the words "saccharin solution, dulcin solution";
 - (c) by inserting after Article 3 thereof the following Articles:—
 - "33. After the 29th day of May, 1943, no person shall by way of trade use in the manufacture or preparation of any product any saccharin tablets or sweetening tablets.
 - 3B. After the 29th day of May, 1943, no person shall by way of trade use in the manufacture or preparation of any "Food" as defined in the Manufactured and Pre-Packed Foods (Control) Order, 1942(b), any saccharin solution, dulcin solution, saccharin in powder form, dulcin, soluble saccharin or sweetening powder; provided that saccharin solution, saccharin in powder form and soluble saccharin may be used in the manufacture or preparation of any "soft drink" as defined in the Soft Drinks (Licensing and Control) Order, 1942(c).
 - 3c. After the 24th day of July, 1943, no person shall, except under and in accordance with the terms of a permit, licence or other authority granted by or on behalf of the Minister for the purposes of this Order—
 - (a) engage in the manufacture of saccharin in powder form, dulcin in powder form, soluble saccharin, saccharin tablets or sweetening tablets;
 - (b) obtain or supply or offer or agree to obtain or supply otherwise than by retail any saccharin solution, dulcin solution, saccharin in powder form, dulcin in powder form, soluble saccharin or

sweetening powder, provided that the restrictions imposed by this paragraph shall not apply to the obtaining or supply of saccharin solution, saccharin in powder form or soluble saccharin for pharmaceutical purposes."
