

# RESEARCH PRIVACY NOTICE

#### **ABOUT US**

This Privacy Notice explains the nature of the personal information that the University of Reading processes for the purposes of conducting research.

The University and the Henley Business School (**We** or **Us**) are data controller in respect of the information that We process about you. This notice explains what personal information We collect, hold and share in support of these research purposes and your rights in respect of the data We hold about you.

#### DATA WE COLLECT ABOUT YOU

To manage our research activities effectively and meet certain legal requirements, We need to collect, record, store, use, share, retain and destroy (this is known as 'processing') your personal data. When you take part in a research study, complete a research questionnaire, or a market research survey, We will collect and process a number of different types of personal data.

We collect personal data directly from you in order to:

- conduct market research into the effectiveness or quality of, or engagement with, the services we offer as an organisation, for example requesting feedback on our courses or events
- conduct scientific research and make provision for research and the advancement, preservation, dissemination and application of knowledge, including innovation and the provision of advisory services for or in conjunction with other institutions, organisations or public bodies as defined within our Royal Charter
- record and retain, as necessary, evidence of consents for the purposes of meeting ethical requirements for research participants
- maintain databases of research participants that elect to be contacted for further studies or wish to receive further communications, including marketing communications, from Us
- perform internal statistical and reporting

# OUR LAWFUL BASIS FOR USES OF YOUR DATA

The University of Reading collects, analyses, uses, shares, and retains personal data for the purposes of research in the public interest. Under data protection law We are required to inform you that this use of the personal data We may hold about you is on the lawful basis of being a public task in the public interest and where it is necessary for scientific or historical research purposes. If you withdraw from a research study, which processes your personal data, dependant on the stage of withdrawal, We may still rely on this lawful basis to continue using your data if your withdrawal would be of significant detriment to the research study aims. We will always have in place appropriate safeguards to protect your personal data.

If We have included any additional requests for use of your data, for example adding you to a registration list for the purposes of inviting you to take part in future studies, this will be done only with your consent where you have provided it to Us and should you wish to be removed from the register at a later date you will be provided with a contact to make this request as part of the information provided as part of each study.

#### WHO WE SHARE YOUR DATA WITH

As all research studies are different, you will be informed of any external parties that We may share your personal data with prior to submitting your personal information, for example before you complete an online survey or questionnaire. These external parties may include, but are not limited to; other Higher Education Institutions involved in collaborative studies, other authorised academics, other public bodies or authorities that are involved in the research being conducted, and external companies that We work with. Your personally identifiable data will only be shared where there is a legitimate need in order to meet the purposes of the research. If you have any queries regarding the sharing of your personal data, please consult the study convener prior to submitting your responses.

Where personally identifiable data is shared We will always ensure that we have measures in place to protect your data and that those third parties will also process your data in line with all applicable data protection laws and ethical standards.

#### TRANSFERS OUTSIDE THE EU

The conducting of research can involve multinational collaborative working and your personal data may be transferred outside of the EU where data protection laws can differ to those within the EU. Where personally identifiable data is shared outside the EU, We will always ensure that we have measures in place to protect your data and that those third parties will also process your data in line with all applicable EU data protection laws. Your personally identifiable data will only be shared where there is a legitimate need in order to meet the purposes of the research. If you have any queries regarding the transfers of your personal data outside the EU, please consult the study convener prior to submitting your responses.

We may also use third party providers to process research data, such as externally hosted databases, software or cloud providers that may be based outside the EU. Were we do this, We will ensure We have measures and terms in place with those providers to ensure that they also protect your data

#### **RETENTION OF YOUR DATA**

As all research study retention needs are different, the timescales that your personal data will be held by Us can vary. In all cases, the researcher conducting the study you are participating in will consider at what point your personally identifying data can be anonymised. Where there are no legitimate needs to retain personally identifiable data it will be deleted, however for some research studies, in particular those involving follow up or repeated questions over a period of time, it will be necessary to retain your personal data in order to do this. Where this applies this will be explained to you prior to completing the survey or questionnaire. We will always take steps to minimise the amounts of personal data being used during your research study, which can include assigning you a pseudonymised reference while we work with your data and keeping your personally identifiable information stored separately and securely.

Under data protection laws, personal data may be stored for longer periods insofar as the personal data will be processed solely for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes. This means that, subject to having safeguards to protect your data in place, including the use of pseudonyms, we may retain personal data collected for research purposes for significant periods of time providing we can evidence a justified reason for doing so.

# KEEPING YOUR INFORMATION UP TO DATE

The accuracy of your information is important to Us. If you have elected to be added to a research participant database or registry for future contact, and wish to remove yourself or update your contact details, you can do this at any time by contacting your study convener. These details will be made available to you at the point you take part in the study.

### **YOUR RIGHTS**

Under data protection law you have the right to:

- Withdraw your consent where that is the legal basis of our processing, for example where you have elected to be added to a participant list or register for future studies or marketing communications
- Access your personal data that We process about you (please note exemptions may apply
  where access to data could detriment the purposes of a research study, Where this is the case
  you will be informed of this in response to any request made)
- Rectify inaccuracies in personal data that We hold about you
- Be erased, that is your details to be removed from systems that We use to process your personal data (please note, this right does not apply to research data held for a public task in the public interest or if erasure would seriously detriment the research study. Where this is the case you will be informed of this in response to any request made)
- Restrict the processing in certain ways
- Obtain a copy of your data in a commonly used electronic form (please note this right does not apply to research data held for a public task in the public interest)
- Object to the processing of your personal data by Us
