



# POLITICAL LIMBO



**Dr Reuven (Ruvi) Ziegler**, Director of Postgraduate Taught Programmes

As an aspiring postgraduate law student at Oxford University, Dr Ruvi Ziegler's MPhil thesis focused on electoral participation of convicts from an international and comparative law perspective. He queried the potentially adverse effects of exclusion of convicts as members of their political communities and on protection of their rights.

Continuing his intellectual journey, Ruvi's doctorate appraised the unique political predicament of refugees, who are, in the main, in political limbo for an indeterminate period.

Since completing his doctorate, Ruvi has become an authority in matters pertaining to International Refugee Law, recognised as a Senior Research Associate of the Refugee Law Initiative and Editor-in-Chief of its working paper series. Ruvi has also established himself as a global expert on questions of political membership and participation, contributing to the work of

the International Democracy and Electoral Assistance, the GLOBALCIT observatory at the European University Institute and the European Union.

From law student to change agent and social reformer, Ruvi has been able to make a real impact on policy and practice. Recently, much of his academic work, as well as public advocacy, has focused on the effects of the 2016 EU referendum on citizens' rights on both sides of the channel.

Speaking at the Liberal Democrat 2018 Autumn conference, Ruvi argued that citizens of other EU countries who are long-term residents in the UK should be granted full voting rights to foster their inclusion. The Conference adopted a policy motion supporting this radical legislative change. He also succeeded in moving amendments to the Liberal Democrat's new Migration Policy that commits the party to a world-leading progressive and modern approach to asylum.

Recently, Ruvi co-authored a letter to the Israeli Attorney General, signed by 50 leading academics the world over, imploring him not to authorise plans to forcibly deport Eritrean and Sudanese asylum seekers from Israel. The controversial policy was averted with Israel's announcement of cancellation of deportation orders and the subsequent renewal of permits.

As an academic who is regularly involved in presenting contemporary issues in government forums and the media, Ruvi's teaching and seminar discussions link theory with burning political issues. Whether referring to the Israel-Palestine conflict while teaching international human rights law, or referring to the electoral rights of non-resident British citizens in his teaching of UK Public Law, Ruvi encourages energetic debate in class and an active contribution from his students.

“The challenge was to look at where the law stands and how it needs to be developed. The sense of accomplishment is in being able to set out ideas, engage with scholars, advocate ideas in relevant forums and pursue them until you achieve the desired long term impact.”

# EFFECTIVE REFORMS



Dr Bolanle Adebola

Dr Bolanle Adebola, Associate Professor in International Commercial Law at Reading, is a trained advocate with dual qualifications: Barrister and Solicitor of the Supreme Court of Nigeria. Her research and teaching span three broad areas of commercial law. These include international corporate insolvency and restructuring law, international corporate governance and finance, as well as international commercial arbitration. Her interest in corporate and commercial law stemmed from the cases she worked on during her brief time in legal practice.

Bolanle came to the UK for a Master's degree in 2007, during which she was introduced to corporate insolvency law as a course of study. She focused her dissertation on a comparative analysis of her most notable insolvency case during her period of legal practice. The dissertation became the basis for her doctoral studies as she sought to propose recommendations for the reform of the corporate insolvency and restructuring law in Nigeria and beyond. Her core research focus has thus been on international insolvency and restructuring law, ever since. Beyond her teaching, Bolanle engages actively in capacity building in both advanced and emerging economies. In 2021, she contributed to judicial training in both Nigeria and the US. In Nigeria, she was invited by the Attorney General Alliance Africa Partnership (AGA) and the Nigeria Judicial Institute (NJI), to participate in the training of justices of the Federal High Court and Court of Appeal of Nigeria. In the US, she was invited by the National Conference of Bankruptcy Judges of the United States. Both workshops focused on knowledge exchange between bankruptcy practitioners and judges.

Many of Bolanle's students are from emerging economies across the globe. During her classes, she discusses broad principles of law, as well as their policy underpinnings within both advanced and emerging contexts. This ensures that her students can apply their new knowledge to the realities of their preferred jurisdictions. She encourages students to undertake comparative studies that highlight lessons that can be learnt from both advanced and emerging economies.

With the aim to help emerging economies make their own laws, Bolanle founded and convenes the Commercial Law Research Network Nigeria (CLRNN), a network established to promote research and knowledge exchange on matters relating to the development and reform of commercial law in economies such as Nigeria. Funded by the Arts and Humanities Research Council (AHRC) Research Networking Scheme, CLRNN seeks to (i) influence the reform of commercial law in emerging economies, (ii) encourage the development of research in such jurisdictions and (iii) facilitate the dissemination of research from such jurisdictions. In Summer 2021, CLRNN broadened its remit through the CLRNN Spotlight on Corporate Governance and Insolvency Law in Africa seminar series, which looks more across Africa.

"Every week the network publishes something for people to read on their website and it's been interesting to see just how responsive people have been. All of that is bringing the emerging economies onto the world stage where our conversations are now being had on a level that is more at par."

# INSURANCE LAW

The teaching of Insurance Law is an exciting new development at the University of Reading. The School of Law will soon introduce a module in Insurance Law, and it is intended to expand LLM teaching into the related maritime law field.

Insurance is essential to every aspect of commercial and private life, and indeed explains many of the legal disputes that come before courts worldwide. Inexplicably, very few institutions teach the subject.

Most people have been involved with insurance claims of one form or another, ranging from minor property damage to accidents at work or on the road. However, the importance of the subject becomes even more apparent when there is a major catastrophe, for example, a collision at sea leading to damage and oil pollution, or a series of destructive earthquakes.

The subject hit the headlines in recent times with claims by businesses forced to close or restrict their activities due to the COVID-19 pandemic, leading to a series of complex and lengthy court cases brought to recover compensation under business interruption insurance policies.

The School of Law has an unparalleled team of experts with experience in every aspect of insurance law.

Dr Kyriaki Noussia, Associate Professor in Commercial Law, has practical experience as a lawyer and has published in the field of insurance regulation, dispute resolution and new technologies. She is particularly interested in environmental issues arising from oil and gas, and has received numerous grants from prestigious bodies to further her research.

Professor Rob Merkin QC has been teaching, researching and writing on insurance law for many years. His most recent work *Marine Insurance: A Legal History* is a study of the development of the law from earliest times up to the turn of the 20th century. He was a Parliamentary adviser on the Law Commission proposal that ultimately became the Insurance Act 2015, and has since advised overseas governments on potential changes to their insurance laws.

Both Kyriaki and Rob are members of the Executive Committee of the International Association of Insurance Law (AIDA) and along with two other colleagues from AIDA are preparing a new multi-volume 'Encyclopaedia of Insurance Law' which draws upon contributions from practising and academic lawyers in many countries.

Lecturer in Commercial Law, Dr Yong Han has authored the monograph *Policyholder's Reasonable Expectations* (Hart Publishing 2016) and has co-edited *Carter v Boehm* and *Pre-Contractual Duties in Insurance Law: A Global Perspective after 250 Years* (Hart Publishing 2018), an important collection of essays on Utmost Good Faith in Insurance.

Peter Tyldesley, Lecturer in Common Law, is a solicitor who worked as an insurance underwriter and a consultant to the Insurance Ombudsman Bureau — a forerunner to the present Financial Ombudsman Service. He then went to work for the English Law Commission, and was the solicitor responsible for preparing proposals that ultimately passed into law as the Consumer Insurance (Disclosure and Representations) Act 2012.

The School of Law also welcomes Honorary Professor John Birds, a world-leading expert in insurance and company law. His work *Modern Insurance Law*, now in its eleventh edition, is widely recognised as the standard student text on the subject. He is also the lead editor of *MacGillivray on Insurance Law* – an established authority and trusted work among insurers, brokers, and practitioners.

Although insurance law is a fascinating area of study, both for its history and for its pervasive influence, perhaps the most important aspect is just how much you learn about the real world and the way in which businesses carry out their operations.

# RESEARCH THAT CHANGES LAW

**The School of Law at Reading is a hub for high-quality research and teaching with impact.**

Our academics are established legal scholars who feed their acknowledged expertise into teaching, thus enriching the learning experience for our students.

Our academics undertake a wide variety of individual and collaborative research, much of which has made a discernible impact beyond the school. Aside from challenging the preconceptions of law, much of our academic research subjects the process of legal decision-making to strict analysis, often igniting debate and challenging governments and policy-makers to redress the balance from a legal perspective.

From court decisions and public policy made by central and local government and international organisations, to the activities of NGOs and charities, we aim to create positive

change. Our subject experts undertake a wide variety of research, around themes such as Global Law; Justice, Rights and Legal Theory; Family, Gender and Sexuality; Public Policy; Legal History; Property, Transactions and Markets; Commercial Law and Financial Regulation.

Our recent research projects include: the changing legitimacy of health and safety, 1960–2015; the international legal regulation of detention in armed conflict; public attitudes towards – and justifications of – retention of the death penalty; and Civil partnership dissolution – expectations and experiences.

As a University of Reading law student, you will benefit directly from this and further research projects, as our academics encourage lively debate around their findings and invite their students to join them in thinking beyond existing laws and policies, to create positive change at a national and global level.

We provide specialised LLM programmes that underpin the relationship between legal systems and the legal regulation of human rights, armed conflict, refugee movement, the use of force and other contemporary areas of global governance. You will engage with academics working at the forefront of research in these areas giving you unparalleled insights to help you forge a path in your career.

## GLOBAL LAW AT READING (GLAR)

Global Law at Reading (GLAR) has an international reputation for research excellence in public international law, EU law, and human rights law. Our academics publish leading works in these fields and many frequently engaged in policy and practice in both the UK and overseas.

To support a thriving postgraduate community, GLAR hosts the Gandhi Research Seminar Series, which attracts internationally renowned speakers from around the world. Students on our global law programmes benefit from significant networking, conference and work experience opportunities.

## LLM ADVANCED LEGAL STUDIES

The LLM Advanced Legal Studies promotes a critical awareness of the methodology of the common law and further develops students' knowledge of substantive subject areas within the English Legal System, with the opportunity to also explore international and human rights law. All students will be required to undertake the compulsory module in research methods and a dissertation together with optional modules including some commercial law options.

### LLM International Law

# INTERNATIONAL COMMERCIAL LAW

**Studying on our International Commercial Law programmes will provide an invaluable opportunity to acquire a unique legal and multidisciplinary perspective of commercial law issues.**

**Offered in conjunction with the International Capital Market Association (ICMA) Centre of Henley Business School, our programmes allow you to tailor your studies with a number of pathways to help you develop your commercial law expertise and specialise in an area of interest. This is a unique aspect of our programmes, which unlike other universities offers students the opportunity to develop a multidisciplinary perspective by studying business-related modules directly from a business school**

## CENTRE FOR COMMERCIAL LAW AND FINANCIAL REGULATION (CCLFR)

The School of Law and the ICMA Centre have established the CCLFR as a forum for conducting research and disseminating knowledge on international commercial law and financial regulation. CCLFR focuses on advancing legal scholarship, brings together scholars and policymakers in law and finance and influences the development and application of commercial law and financial regulation in practice through research projects, conferences, teaching and publications.

## LLM INTERNATIONAL COMMERCIAL LAW

The LLM International Commercial Law provides an overview of the main commercial law issues that arise in a multiplicity of transactions. It covers those aspects of law that practitioners could expect to encounter on a regular basis, including banking law, competition law, and intellectual property law. The overarching aim of this LLM programme is to facilitate the recognition and appreciation by students of international commercial law and permits detailed study of some aspects of law. This programme will be relevant to graduates

or professionals aspiring to work in law firms, multinational corporations, government agencies, international financial institutions, the judiciary and academia (subject to further study).

All students selecting a pathway will study Advanced Issues in International Commercial Law and International Corporate Finance and the Law, together with the specified module(s) for your chosen pathway, and a written project related to that area of law.

## LLM INTERNATIONAL COMMERCIAL LAW WITH CORPORATE FINANCE

The aim of this pathway is to analyse the different aspects of corporate finance from an international perspective. This LLM programme will provide the tools to recognise the key elements to implement a successful financing technique by means of the analysis of theoretical issues and actual case studies. You will develop an understanding of the basic corporate framework at the national, regional and trans-national level. You will be aware of different financing techniques and have a broad understanding of the theory and practice of the capital markets and financial regulation in a comparative context.

## LLM INTERNATIONAL COMMERCIAL LAW WITH BANKING LAW AND FINANCIAL REGULATION

This pathway addresses financial regulation and supervision with a specific emphasis on banking and securities law. The programme tackles regulatory and legal control of financial markets and financial intermediaries including banks (commercial banks and investment banks), as well as securities firms, insurance undertakings and other more specialist types of service provider, and financial conglomerates. You will take compulsory and optional modules at the School of Law and ICMA Centre, Henley Business School, having the opportunity to develop a holistic perspective of the legal and financial issues and to enhance your employability prospects in the financial sector.

## LLM INTERNATIONAL COMMERCIAL LAW WITH INTELLECTUAL PROPERTY LAW AND MANAGEMENT

Intellectual property has a central role in the enhancement of creativity, innovation, entrepreneurship and commercial growth in the modern economy. The first and only LLM in the UK offering Law and Management of Intellectual Property, this pathway is designed to respond to the emergent demand for professionals who have studied intellectual

property to a high level. This pathway will also provide you with the opportunity to develop an advanced understanding of the theoretical underpinnings of intellectual property law and an ability to critically assess and provide practical solutions to problems of the type commonly encountered in intellectual property law. You will be able to identify the key challenges for organisations involved in the production or distribution of cultural products and services, and analyse the various ways in which organizations have responded to these challenges in different commercial and cultural contexts.

Following completion of her LLM at Reading, Nudchanard achieved her ambition of becoming a practitioner in International Commercial Law. She is now a legal officer in a Thai state-owned oil and gas company, which is the only company in Thailand to be listed in the Fortune Global 500. Nudchanard believes the skills and knowledge she acquired from her studies at Reading helped her secure this job.

Students undertake postgraduate study at two institutions in the form of a double master's programme, completing two master's programmes in two years. We offer double master's courses with a range of leading partner universities worldwide.

The double master's opportunity is only available to students studying at our partner universities. Students from our partner universities who are joining our Commercial Law master's programmes may be eligible for a discount on the University of Reading tuition fees.

**At the School of Law, our master's by research course aims to provide you with an advanced set of skills that will serve you well within legal research or a wide range of other careers.**

## **MA BY RESEARCH IN LEGAL HISTORY**

Our MA by Research in Legal History is an interdisciplinary programme that equips graduates with a sophisticated understanding of legal and historical approaches to social, cultural and political phenomena, advanced skills in archival research, and the ability to undertake high-level analysis of law and legal issues.

The programme allows students to undertake detailed research in some aspects of legal history and is primarily undertaken through guided research and writing, with each candidate's programme tailored to best reflect their needs, interests and goals. Students will be closely associated with the Law School's Forum for Legal and Historical Research.

This programme is particularly suited to those entering the legal profession or who wish to pursue a PhD in history, law or related areas. Pursued part-time, it is also of great value to people already undertaking academic research or members of the legal profession, especially barristers, who wish to build their skills in legal and historical analysis to contribute to the literature upon which superior courts, parliamentary bodies and law reform agencies frequently rely.

## **MRES LAW AND MRES LAW & SOCIETY**

The Master of Research programmes are suited for students who wish to pursue career paths in research-based positions in national or international government or non-government institutions. The courses also appeal to those who are interested in professional research in law or the administration of justice, or those who wish to pursue a PhD in law or related areas. These degrees equip students with high-level analytical skills and a strong grasp of research methods, research design and research project management skills.

Some of our very best master's level students follow these programmes each year, frequently going on to become PhD candidates. The MRes Law & Society emphasises socio-legal research, the study of law in context and the interplay of legal and social theory. The MRes Law is suitable for candidates who are less focused on the pursuit of interdisciplinary links and who are primarily interested in the study of law as a discrete domain of knowledge and practice.

**Engage in cutting-edge research in your chosen area of law. The School of Law offers a vibrant research culture and welcomes high-quality applicants from all over the world to join a recognised centre of excellence in both doctrinal and socio-legal research across a wide range of areas.**

The School of Law offers two main postgraduate research degrees: PhD (3 years full-time or 4–6 years part-time); LLM by thesis (1 year full-time or 2 years part time)

As a research student, you will join a dynamic and thriving community of postgraduate researchers and you will play an integral part in the life of the School. You will have excellent facilities and support, including research training programmes, informal lunches, faculty seminars, financial support for conferences and career development strategies.

All of our law students have access to the University's Graduate School where there is 24-hour access to study space and a range of up-to-date facilities for the exclusive use of postgraduate research students.

All students embarking on a PhD have regular meetings with their supervisors who are experts in their field, and annual independent monitoring panels ensure that progress is on track and provide additional assistance and support.

The School of Law offers an annual PhD proposal writing workshop. This provides potential applicants with hands-on advice and support to enable them to submit strong research proposals with a view to being offered a place on the doctoral programme and to provide help in securing studentship funding.
