#### Medical Assistance

During an 'Insured Journey' contact RSA Assistance as shown above; if you have already received emergency treatment, contact RSA Assistance at the earliest opportunity and provide the following information:

- Insured and policy numbers detailed on the card
- Your personal details and where you are receiving treatment
- The nature of your medical problem

RSA Assistance will provide advice and all necessary assistance. If RSA Assistance is not contacted, you may be presented with a bill for treatment provided. Please note, however, that if you suffer a minor illness or injury, and do not require advice or Assistance from RSA Assistance, you may make your own arrangements and submit a claim at the end of your "Insured Journey". Many medical facilities will contact RSA Assistance on your behalf, but not all will do so

#### **Security Assistance**

During an 'Insured Journey' where you are involved in a life threatening situation, hi-jacked, kidnapped, illegally detained or need to be evacuated from a country in an emergency, if possible: Call the emergency number detailed above and ask for security assistance Please guote the Insured and Policy Numbers above and provide the following information

- 1. Your personal details & employer/Education establishment
- 2. Your contact details
- 3. Your location
- 4. A brief synopsis of the initial incident and what is happening around you

5. Your call will be handled by a security expert who will immediately assess your situation and initiate an action plan to provide you with as much assistance as possible.

Remain CALM: ASSESS the situation and IDENTIFY any remaining threat and if safe to do so, remain where you are.

**Uninsured motoring assistance** if the Insured Person's vehicle breaks down on the way to the airport. All costs payable by Insured Person. (Please note this service only applies in the UK)

**Uninsured domestic assistance** for the duration of the 'Insured Journey' – RSA Assistance will call out a tradesman to attend to an emergency at home. Repairs and services necessary are payable by the Insured Person. (Please note this service only applies in the UK)

Emergency messages directed to family/employer.

#### **RSA Assistance Identity Theft Helpline**

Over the phone prevention advice, to help an Insured Person safeguard their identity, including guidance on measures to take to re-establish identity and credit rating

#### **RSA Assistance Essential Information Storage**

To enable an Insured Person to securely store important text based information from documents such as passports, driving licence, travel and debit/credit card details and retrieve these details from a secure website in the event of the loss of these documents whilst travelling.
