### **Programme information and content**

The Programme aims provide you with subject-specific knowledge of both International Relations and English Literature. The joint degree seeks to impart knowledge of a variety of different kinds of literary texts, thereby providing a perspective on different methods of critical analysis. In International Relations, the programme aims to give students an appreciation of the normative, methodological and institutional issues involved in the study of this subfield of Politics and International Relations. The course also aims to foster an independent approach to formulating problems and arguments, using the systematic research, close reading and analytical skills that are fundamental to both disciplines.

Throughout the programme, individual modules come with the option of an academic placement which complements and develops the learning on a module. Study Abroad opportunities are also available at Parts 2 and 3.

Part 1:	<p><b>English Literature</b> introduces you to debate about approaches to the study of literature and politics, through critical and research exercises and close study of selected texts from a number of different periods.</p> <p><b>International Relations</b> introduces you to the three strands of the discipline: comparative government, political theory and international relations.</p>
Part 2:	<p><b>English Literature</b> provides you with greater breadth of coverage, and studies texts within historical periods and generic traditions.</p> <p>In <b>International Relations</b>, Part 2 provides you with a more in depth knowledge of the issues of conflict and resolution in society; the research tools we use to investigate and analyse such issues and the strategies states and other actors develop and implement in global International Relations today.</p>

Part 3:	<p><b>English Literature</b> gives you the opportunity to undertake more specialized and independent literary study, choosing your modules from a wide range of options. The dissertation module develops your skills in research, planning and writing.</p> <p>In <b>International Relations</b>, Part 3 offers a wide range of optional modules covering all aspects of politics and international relations.</p>

### Module information

Each part comprises 120 credits, allocated across a range of compulsory and optional modules as shown below. Compulsory modules are listed.

#### In English Literature

Students must select 60 credits of optional modules from the Department of English Literature, with at least 20 credits selected from a list of pre-1800 modules.

#### In International Relations

Students must select 20 credits of optional modules available in the Department of Politics and International Relations.

Up to 20 credits may be replaced by a Work Placement and Project or by modules from elsewhere in the University, subject to approval by the Programme Director.

Students may be permitted to undertake a placement year or a study abroad year between Part 2 and Part 3 of the programme. In such cases students will transfer to a 4-year programme. The placement or study abroad year should not normally be shorter than nine months full-time.

If you take a year-long placement or study abroad, Part 3 as described below may be subject to variation.

### **Part 3 Modules:**

Students must select one 40 credit dissertation module.

Student must select 40 credits of optional modules available in the Department of English Literature.

Student must select 40 credits of optional modules available in the Department of Politics and International Relations.

Up to 20 credits may be replaced by a Work Placement and Project, if not taken previously, or by modules from elsewhere in the University, subject to approval by the Programme Director.

### **Optional modules:**

The optional modules available can vary from year to year. An indicative list of the range of optional modules for your Programme is set out in the Further Programme Information. Details of optional modules for each part, including any Additional Costs associated with the optional modules, will be made available to you prior to the beginning of the Part in which they are to be taken and you will be given an opportunity to express interest in the optional modules that you would like to take. Entry to optional modules will be at the discretion of the University and subject to availability and may be subject to pre-requisites, such as completion of another module. Although the University tries to ensure you are able to take the optional modules in which you have expressed interest this cannot be guaranteed.

### **Additional costs of the programme**

During your programme of study you will incur some additional costs.

For **English Literature** textbooks and similar learning resources, we recommend that you budget between £150 to £250 a year. Some books may be available second-hand, which will reduce costs. A range of resources to support your curriculum, including textbooks and electronic resources, are available through the library. Reading lists and module specific costs are listed on the individual module descriptions.

For **International Relations** textbooks and similar learning resources, we recommend that you budget between £400 to £500 a year. Some books may be available second-hand, which will reduce costs. A range of resources to support your curriculum, including textbooks and electronic resources, are available through the library. Reading lists and module specific costs are listed on the individual module descriptions. specific costs are listed on the individual module descriptions.

Printing and photocopying facilities are available on campus at a cost of £0.05 per page.

Costs are indicative and may vary according to optional modules chosen and are subject to inflation and other price fluctuations.

The estimates were calculated in 2020.

## **Placement opportunities**

### **Placements:**

You may be provided with the opportunity to undertake a credit-bearing placement as part of your Programme. This will form all or part of an optional module. You will be required to find and secure a placement opportunity, with the support of the University.

### **Study Abroad:**

You may be provided with the opportunity to undertake a Study Abroad placement during your Programme. This is subject to you meeting academic conditions detailed in the Programme Handbook, including obtaining the relevant permissions from your School, and the availability of a suitable Study Abroad placement. If you undertake a Study Abroad placement, further arrangements will be discussed and agreed with you.

## **Teaching and learning delivery:**

You will be taught through seminars, lectures and individual consultations.

Total study hours for each Part of your programme will be 1200 hours. The contact hours for your programme will depend upon your module combination; an average for a typical set of modules on this programme is Part 1 - 228 hours, Part 2 - 132 hours, Part 3 - 132 hours. In addition to your scheduled contact hours, you will be expected to undertake guided independent study. Information about module contact hours and the amount of independent study which a student is normally expected to undertake for a module is indicated in the relevant module description.

## **Assessment**

Assessment is conducted through a mixture of assessed essays and formal examination.

### **Progression**

The University-wide rules relating to 'threshold performance' as follows

#### *Part 1*

- (i) obtain an overall average of 40% over 120 credits taken in Part 1; and
- (ii) obtain a mark of at least 30% in individual modules amounting to at least 100 credits taken in Part 1.

In order to progress from Part 1 to Part 2, a student must achieve a threshold performance; and

- (iii) obtain a mark of at least 40% in the compulsory English Literature module EN1RC, and obtain a mark of at least 40% in either of the compulsory English literature modules EN1GC or EN1PE, at Part 1; and

(iv) obtain a mark of at least 40% in all compulsory modules in Politics and International Relations at Part 1 (PO1ICD, PO1IPI, PO1IRS).

The achievement of a threshold performance at Part 1 qualifies a student for a Certificate of Higher Education if they leave the University before completing the subsequent Part.

### *Part 2*

To gain a threshold performance at Part 2, a student shall normally be required to:

- (i) obtain a weighted average of 40% over 120 credits taken at Part 2; and
- (ii) obtain marks of at least 40% in individual modules amounting to at least 80 credits; and
- (iii) obtain marks of at least 30% in individual modules amounting to at least 120 credits, except that a mark below 30% may be condoned in no more than 20 credits of modules owned by the Department of Mathematics and Statistics.

In order to progress from Part 2 to Part 3 in the **3 year programme**, a student must achieve a threshold performance

In order to progress from Part 2 to Part 3 in the **4 year programme**, a student must achieve a threshold performance and obtain a pass in the professional/work placement or study abroad year. Students who fail the professional/placement year transfer to the non-placement year version of the programme.

The achievement of a threshold performance at Part 2 qualifies a student for a Diploma of Higher Education if they leave the University before completing the subsequent Part.
